MASS-PRODUCED GOODS PERMITTED. LIMITED, SIGNED PRINTS WILL BE
ACCEPTED. ALL WORK
DISPLAYED MUST BE FOR SALE.

JURY:

ARTISTS WILL REPRESENT THE DIFFERENT CATEGORIES LISTED. THE JURY
WILL JUDGE EACH CATEGORY, WITH THE GOAL OF CHOOSING BOTH THE MOST
QUALIFIED IN EACH CATEGORY AS WELL AS A REPRESENTATION OF THE
EXAMPLE.

THREE IMAGES WILL BE ACCEPTED WITH EACH ENTRY. PLEASE MAKE YOUR
IMAGE DESCRIPTIONS CLEAR AND CONCISE ON THE APPLICATION FORM. **ALL
WORK WILL BE JUDGED ON ORIGINALITY AND CRAFTSMANSHIP.**

EXCELLENCE HONORED:

SELECTED ARTISTS WILL BE AWARDED FOR OUTSTANDING EXCELLENCE.

FEES:

JURY - \$10 NONREFUNDABLE

ENTRY - \$90 REFUNDABLE IF NOT ACCEPTED

DISPLAYS:

DISPLAYS MUST NOT EXCEED 10' X 10'. PLEASE NOTE THAT MOST SITES
ARE ON A SLIGHT GRADE.

WEATHER POLICY:

GLENSHEEN IS LOCATED DIRECTLY ON THE SHORES OF LAKE SUPERIOR.
EXHIBITORS MUST BE PREPARED FOR ALL TYPES OF WEATHER. IN
THE EVENT OF BAD WEATHER, THE FESTIVAL WILL NOT BE CANCELED NOR
WILL REFUNDS BE ISSUED.

GOOD BUSINESS PRACTICE POLICY:

EXHIBITORS NEED TO HOLD PROPER TAX PERMITS FOR BOTH MINNESOTA AND DULUTH. A FORM VERIFYING TAX INFORMATION FOR MINNESOTA WILL BE REQUIRED OF ALL EXHIBITORS AND THIS FORM WILL BE SENT WITH ACCEPTANCE NOTICES.
